Licensing Classifications

The NSA issues unrestricted licenses, which permit the licensee to compete in all races sanctioned by the NSA, as well as licenses restricted to training flat races ("Flat Races") only, or flat races and timber or hurdle races only. By checking the appropriate box(s) below, you may apply for an unrestricted license, or a license restricted to one or more categories, but the determination as to which license will be issued to you will be made by the Stewards Advisory Committee based upon your background and experience in riding over different courses. All successful applicants will be permitted to ride in flat races. In order to compete in hurdle and timber races, an applicant must demonstrate the ability to jump fences and to compete in hurdle races, the ability to do so at speed. During the period in which a license is valid, a jockey may request that his/her license be modified to permit him/her to compete in one or more additional categories of races by request to the Stewards Advisory Committee and submitting information showing his/her ability to compete satisfactorily in the desired race category.

CONDITIONS OF LICENSE

This license is subject to the conditions stated herein and by his/her signature hereto the licensee ("Jockey") acknowledges that he/she has read these conditions, understands them, and agrees to be bound by them at all times.

- 1. I confirm that the information given in this application for a jockey's license is correct and hereby request that my application receives the consideration of the National Steeplechase Association ("NSA") Board and I declare that, should a license be granted to me, I agree to be bound in all respects and at all times abide by the rules of racing of all racing authorities, including but not limited to the National Steeplechase Association, all regulatory racing authorities and any recognized Turf Authority concerned when riding abroad, as the case may be.
- 2. Jockey further agrees to be bound by any conditions printed in any condition book, by any conditions or requirements imposed by the owner of the premises or by the Race Committee or sponsoring organization of any NSA sanctioned meet, and by any conditions promulgated or imposed by the National Steeplechase Association or the Stewards at an NSA race meeting.
- 3. As further consideration for the grant of a license to participate in any NSA sanctioned race meeting or event, the Jockey expressly assumes any and all risk whether foreseeable or not, including all risks associated with steeplechase events such as risks associated with equine activities (including without limitation the propensity of an equine to behave in dangerous ways, which may result in injury to the participant, the inability to predict an equine's reaction to sound, movements, objects, persons, or animals, and hazards of surface or subsurface conditions), risks associated with sporting events, risks associated with spectator events where alcohol is served or consumed, with respect to participation or presence in any capacity in or at any NSA race meeting or event and agrees to the extent permitted by applicable law as follows:
 - (A) Jockey shall be responsible and liable for any and all injury, including, but not limited to, physical injury, economic or pecuniary injury, mental or emotional injury, or property damage arising from, related to, based upon, or attributable to the acts or omissions of Jockey, his/her agents and employees.
 - (B) Jockey shall indemnify the sponsoring committee, race committee, racing association/racetrack; any charity or other beneficiary who may benefit from the races, the NSA; the owners, lessees, lessors, or licensees of any premises where a race meet may be held; all directors, officers, trustees, agents, employees, servants and licensees of any entity included in this paragraph (B), (hereinafter the "Indemnified Parties"), from any claim arising from, related to, based upon, or attributable to the acts or omissions of Jockey, his/her agents, and employees.
 - (C) Jockey waives his/her rights against and forever discharges and releases the Indemnified Parties identified in paragraph (B) from liability for any claim which Jockey may now or hereinafter have for any injury including, but not limited to, physical injury, economic or pecuniary injury, mental or emotional injury, or property damage arising from, related to, based upon, or attributable to any act or omission of the Indemnified Parties identified in paragraph (B), jockeys, owners, trainers, any and all licensees of the NSA, spectators, and any and all third parties.
 - (D) Jockey waives his/her rights against and forever discharges and releases all jockeys, owners, trainers, and any and all licensees or members of the NSA, from liability for any claim which Jockey may now or hereinafter have for any injury, including, but not limited to, physical injury, economic or pecuniary injury, mental or emotional injury, or property damage arising from, related to, based upon, or attributable to any act or omission of the Indemnified Parties identified in paragraph (B), jockeys, owners, trainers, any and all licensees or members of the NSA, spectators, and any and all third parties.
- 4. If a Jockey experiences a fall or other racing accident, the Jockey hereby agrees to submit to a physical examination by the course physician as a prerequisite to receiving permission to ride in any subsequent race.

I consent to the release of any medical information pertaining to any accident or injury sustained in the course of my duties as a licensed jockey to the National Steeplechase Association and/or its appointed medical designates. I understand that this information will be used only for documentation purposes and to facilitate appropriate medical care.

By my signature hereto, I confirm that I have read this application for a license in its entirety, I understand it, and I agree to be governed by it, and I expressly agree to abide by the insurance requirements that are a condition precedent to the grant of my license.
