**RE: In the Matter of the Appeal of Gerard Galligan**

### ORDER

In the above appeal, the Hearing Review and Appeals Committee, after hearing conducted on January 24, 2017 at the offices of the National Steeplechase Association, affirms and upholds the findings of the Stewards at the Montpelier Races on November 5, 2016 and of the Stewards Advisory Committee on November 9, 2016 and affirms and upholds the following penalties:

Jockey Gerard Galligan, for violation of Rule 7.7.B.2 (reckless and dangerous riding), is fined \$500.00 and suspended one steeplechase day Saturday March 25, 2017.

Jockey Gerard Galligan, for misconduct in the jockeys' quarters, is fined \$250.00.

Jockey Gerard Galligan, for violation of Rule 5.2.B.3 (misconduct during the Stewards' hearing), is suspended one steeplechase day, Saturday April 1, 2017.
