There will be an Officials meeting immediately following the jockey meeting at the Stewards stand.

There will be a mandatory pre-race veterinarian exam with Dr. Liz Barrett. LASIX HORSES MUST BE ON THE GROUNDS 4 HOURS PRIOR TO POST TIME FOR THEIR SCHEDULED RACE. ALL HORSES MUST BE ON THE GROUNDS 2 HOURS PRIOR TO POST TIME FOR THE FIRST RACE UNLESS EXCUSED BY THE STEWARDS FOR EXTENUATING CIRCUMSTANCES.

THIRD PARTY FUROSEMIDE (SALIX) ADMINISTRATION - Horsemen are reminded that third party administration of furosemide (Salix) is in effect at this race meet. Please refer to the 2018 NSA Fall Condition Book (center green section) for complete details of the NSA Medication policy. Contact Dr. Jeff Witwer (803-243-0328).

Foal papers are not required to be on file with the Horse Identifier at the races providing the horse can be properly identified; and tattoos are required for all horses, with a one-time exception providing the horse can be identified by its markings. All scratches must be made no later than one hour prior to post time for the first race.

#### DIRECTIONS

All NSA Steeplechase trailers need to enter through the Kentucky Horse Park Main Entrance. Please ask the gate attendant for a red High Hope "Stables" parking pass, and please hang immediately from your mirror. At the circle, take the second right onto Cigar Lane. Turn right onto Nina Bonnie Road at the four-way intersection. Continue straight on this road, past the steeplechase barn to the temporary barn in the open area directly across from the Rolex Arena. Volunteers will be directing High Hope traffic. Park all trailers behind stabling area.

All horses must have a current Coggins and health certificate as every horse may be checked on entry to the Kentucky Horse Park.

ATTENTION HORSEMEN: Two bags of shavings will be provided for each stall. To purchase additional bags of shavings or hay, call Dever, Inc. (on site at the Kentucky Horse Park) either prior to race day or day of event, 859-233-9702.

MEMBERS PAVILION TENT AT HIGH HOPE - All owners, trainers and NSA officials may enjoy two complimentary tickets to the Members Pavilion Tent on the hill across the track from the Announcer's Tower, but must RSVP to High Hope office prior to race day to be on the list. Please RSVP at: 859-967-9444.

Grooms will be offered food and water in the Stabling Tent. Jockeys will have lunch provided in the Jockey Tent.

TRAINER BONUS AWARDS- There will be trainers' bonuses awarded to the three most successful trainers of the day - \$1,200, \$750, and \$500 on a points system as follows: 4 points for the winner; 3 points for second; 2 points for third; and 1 point for each starter.

JOCKEY AWARD - The Jonathan Kiser Perpetual Trophy will be awarded to the jockey who wins the most jump races at High Hope. The winner will receive \$1,000 and a Julep Cup. The winner's name will be engraved on a perpetual trophy.
