There will be a pre-race vet check performed by Dr. Charles Arensberg, Dr. Kathy Anderson and Dr. Bernadette Loomis-Smith beginning at 11:30 a.m. ALL HORSES MUST BE ON THE GROUNDS 2 HOURS PRIOR TO POST TIME FOR THE FIRST RACE (IF NOT ON LASIX) FOR THE PRE-RACE VET CHECK UNLESS EXCUSED BY THE STEWARDS FOR EXTENUATING CIRCUMSTANCES. LASIX HORSES MUST BE ON THE GROUNDS 4 HOURS PRIOR TO POST TIME FOR THEIR SCHEDULED RACE.

#### THIRD PARTY FUROSEMIDE (SALIX) ADMINISTRATION

Horsemen are reminded that third party administration of furosemide (Salix) is in effect at this race meet. Please refer to the 2019 NSA Spring Condition Book (center pink section) or the NSA Official Notices for complete details of the new NSA Medication policy. Contact Dr. Jeff Witwer (803-243-0328).

Foal papers are not required to be on file with the Horse Identifier at the races in claiming races providing the horse can be properly identified; and tattoos or microchips are required for all horses, with a one-time exception providing the horse can be identified by his/her markings.

NOTICE: Only those with Green parking hang tags are permitted to park in the lot behind the National Steeplechase office or the TRA lot. All others with gold or NSA OTR hang tags must enter at Road 2 off Rt 273 (Telegraph Road).

O/T/R hospitality will be located in the lower portion of the Tea Barn. NSA credentials will be honored.

Turf: Turf consists of fescue and native grasses 5 inches in height. The turf has a thick cushion

Smoothness: There are several rough sections that will be rolled several times as the weather

Allows. All courses have been aerated and rolled.

Compaction: Average 110 (good)

Moisture: 100 (wet)

Notes: The course was inspected May 13 after 2.5 inches of weekend rainfall. The surface was saturated. Several dry days are predicted this week and the course report will be revised should conditions permit.

Update: The course has been Aggravated and is in good condition.

**DIRECTIONS:**

The Fair Hill Races are located in Cecil County, Maryland, just 15 minutes off I-95, midway between Philadelphia, PA and Baltimore, MD.

**DIRECTIONS FROM THE NORTH:** I-95 South or the New Jersey Turnpike South into Delaware. Continue on I-95 through toll booth into Maryland. Take the first Maryland exit, Route 279 South to Elkton, not Newark, DE. Follow to 3rd Traffic Light. Turn Right on Route 213 North. Go approximately 8 miles to 1st Traffic Light (Junction of Route 213 and Route 273). Turn right onto Route 273. Entrance to Fair Hill Races will be on the right, with additional parking across the street.

**DIRECTIONS FROM THE SOUTH:** I-95 North from Baltimore. After paying the toll at the Susquehanna River Toll Booth, go approximately 7 miles to the Exit 100 (Route 272 North East/Rising Sun). Follow Route 272 North about 5 miles to the traffic light at the intersection of Route 273. Turn right onto Route 273 East toward Newark, DE. Go 5 miles to the traffic light at the intersection of Routes 273 and 213. The entrance to Fair Hill Races is just past the traffic light.

**DIRECTIONS FROM NEWARK, DE:** Route 273 West approximately 5 miles to Fair Hill Races.
